Judy explained that he could appeal the fine. The owner chose not to appeal. Judy suggested that he contact the Tobacco Alliance Director to review any new products to make sure that they are allowable to sell. Judy further explained that the fine will go up.

Update: 56 Singletary Ave. Mr. Bacon had stated that he spoke with Mike Cahill who instructed him to bring his complaint back to the Board of Health. Judy reached out Mike Cahill, State Agriculture and he said if we sent an order letter and the Board was satisfied with the action taken then no further action. He is unfamiliar with surface water and suggested contacting DEP in regards to surface water. Judy stated that Mr. Bacon will be attending our September meeting and asked if the Board wanted to contact DEP. The Board stated Mr. Bacon can contact DEP. Judy will send out the animal inspector before the next meeting for an update on the farm.


Well Regulations Review/Geo Thermal: Cheryl will contact Eli Richardson to attend a future meeting to explain Geo Thermal wells.

Tobacco Control Alliance: Joan Hamlett, Director of the Tobacco Alliance, would like to re-introduce herself to the Board in the fall.




