TCE in Water: No Updates


27 Carrier Lane/Septic Update: On-going issue - had breakout, Jim sent a letter, never came up with a formal plan. John Spoke to the owner 3 or 4 months ago and informed him that he needs to show some progress. John will make another site visit. Send a certified letter stating he has 2 weeks to schedule soil testing and 30 days for an approved plan (the BOH can expedite the approval process) or legal proceedings will be the next step. Cheryl stated this needs to be resolved by spring. DEP is now involved.

189 Burbank Road – Guinea Hens Complaint - Update: Mrs. Kehowski is attending this meeting to discuss the situation. Mr. Kehowski had stopped in after the last meeting and John explained that he can't have his hens on other people's property defecating on their decks. John stated in the end it was a friendly conversation. Diane mentioned a chicken the use of a chicken wire fence. John stated they fly over the fence, as per the owner. Diane said they could clip the wings. John said that the owner said that would make them more vulnerable to hawks. John was expecting Mrs. Kehowski to come to this meeting to discuss this issue. Mrs. Kehowski did not show up. They Board stated to send a letter that they come up with a plan to rectify the situation within 14 days or fines will be implemented. Cheryl stated she spoke with the owner and natural predators are reducing the flock.

Department Update: Judy mentioned that a new vape shop is coming to Sutton. Vaper's Paradise. John attended a meeting with Cheryl and Ray Gauthier at Market 32 and they will tighten up their quality control and John suggested if anyone calls with any bad product and John recommend Cheryl pick up the product as sometimes these complaints can be a disgruntled shopper or ex-employee and want to add some credibility. Ken stated he had an issue with fatty meat and they replaced his product immediately. The office of Dam Safety is trying to get people who own dams to fix these dams. However, these landlocked dams need access from private properties. The office of Dam Safety told these owners that they have to allow access. The concern is flooding of septic systems and wells. Conservation did issued an enforcement order to Curtis Robie in the beginning of September in regards to beaver activity and potential flooding. Mr. Robie is now stating he does not own the Dam. Cheryl stated the BOH has to follow up and address. Cheryl stated it is up t the owner of the property to hire a beaver trapper and the BOH will issue a permit. John stated he will make a fly over site visit. Cheryl stated Flu Clinics are underway. Tomorrow 3 to 7. The dumpsters not being emptied at the schools has been addressed.


