Comments:

Data:

- 1. JW made a brief presentation of site work to be observed by GEI: (1) excavation to prepare for installing the subsurface stormwater infiltration system; (2) about half-way through construction of the subsurface infiltration system and (3) as-built plan/construction completeness review. GEI will also assist the Town of Sutton on an asneeded basis if issues arise. JW asked for a two-day notice for GEI site visits.
- 2. JH requires that all possible changes to the approved site plans need to be presented to her for review. JH will consult with JW as necessary. JH will advise the developer whether the requested changes are minor changes that can be approved by her office or if the developer needs to present the proposed changes to the Planning Board for approval.
- 3. JB no questions at this time. He is attending the meeting due to a conflict in the Fire Chief's schedule.
- 4. JC asked how long it will be until use of the existing driveway from Route 146 will be discontinued in favor of access off Pleasant Valley Road. The developer's team responded that the Pleasant Valley Road entrance is being filled and is now usable, albeit the access point is not yet in accordance with the plans and filling will continue to so that the plan requirements/location are met. The Route 146 driveway has been closed.
- 5. MS asked about work along Pleasant Valley Road. Responses to MS's questions/comments:

- a) Off-site water and sewer are to be installed in the spring.
- b) GD said trees don't have to be taken down for electric utility. Orange stakes or flagging were set out to mark tree trimming to be done.
- c) The developer's team has been in touch with Wilkinson Water and Sutton Sewer Department about running offsite utilities. The Pleasant Valley Road road opening permit application has not been submitted yet.
- d) In MassDOT's review of an access permit application, MassDOT applied larger edge-of-pavement radii at the entrance in their access permit approval to further restrict turning movements to right turns only. An island surrounded by vertical granite curb replaced a smaller mountable island.
- e) The Rte. 146 water main ended at the southern end of the Galaxy site and the applicant decided to pursue connection to the water main in Boston Road.
- 6. JH read through the Site Plan Approval conditions:
 - a) JW to check #1 Compliance with GEI's May 4, 2023 site plan review letter.
 - b) JH asked for a copy of the latest plans with any changes (e.g., MassDOT-required access changes). A cover letter and updated plans are expected to be issued by GD by end of this week.
 - c) Sight lines need to be created and maintained for traffic exiting the new driveway off Pleasant Valley Road. Sight lines need to be maintained during construction as well as long-term. Obstructions such as soil stockpiles, construction equipment and construction materials are to not obstruct sight lines. The contractor will not be placing opaque fabric on the fence where sight lines could be obstructed. As earth filling proceeds, the temporary perimeter fence will be moved as needed.
- 7. Torrington Properties is doing the site construction and constructing the building core and shell. Convenient MD is doing the building fit out once Torrington's work is completed.
- 8. March/April 2024 is the desired finish date for the building shell. The finish date may end up being between the end of April to mid-May.
- 9. Applicant's Team (GD) will provide a list of their meeting attendees.
- 10. JW to prepare a draft of meeting minutes.
