Applications must be submitted in a complete packet in order to schedule a public hearing (please see deadlines for meeting dates).

- A completely filled out Application
- A project description
- Required maps, drawings and/or photographs
- Seven complete copies of the Application and any supporting documents
- An electronic file of the Application and supporting documents
- Certified Abutters List from Assessors
   (Please file with Assessors Office at least 10 days before application is to be submitted)
- Application and mailing fees (to be calculated by the Planning Department) make check payable to Town of Sutton
- Advertising fee \$100.00 check made payable to GateHouse New England
