ARTICLE 1 AUTHORITY: Elected Board SPONSOR: Board of Selectmen

To receive the reports of the Town Officers and Committees.

ARTICLE 2 AUTHORITY: Multiple Member Body SPONSOR: Cemetery Commissioners

To see if the Town will vote to authorize the Cemetery Commissioners to employ themselves in the work of the several cemeteries and to fix the compensation to be paid from appropriations for said department, or act or do anything in relation thereto.

ARTICLE 3 AUTHORITY: Multiple Member Body SPONSOR: Board of Health

To see if the Town will vote to authorize the Board of Health to employ themselves in the performance of their work necessary to maintain health standards set by their department, and to fix the compensation to be paid from appropriations for said department, or act or do anything in relation thereto.

## ARTICLE 10 AUTHORITY: Citizen Petition SPONSOR: Doreen Evangeline

To see if the Town will vote to amend the Zoning Bylaw – Section VI.L Accessory Apartments to allow detached units as follows:

Amend ¶2 sentence #1- An accessory apartment is a dwelling unit constructed within and/or added onto a single family dwelling or a detached accessory building.

Amend b. – Only one (1) accessory apartment shall be allowed per lot.

Amend d. – An accessory apartment shall be designed to maintain the appearance of the single family property of which it is a part, and shall be clearly subordinate to the single family dwelling.

Amend e. – An exterior entrance to the apartment shall be located on the side or rear of the single family dwelling.

Add i. – In order for an accessory apartment to be located within a detached accessory building, the building must be located no more than 75' from the primary residence.

### ARTICLE 11 AUTHORITY: Citizen Petition SPONSOR: Richard Norlin

To see if the Town will vote to raise and appropriate, transfer from available funds in the treasury or borrow under the provisions of MGL c.44, or any other enabling authority, a sum of money not to exceed the sum of \$5,000 for the control of Eurasian Watermilfoil, Fanwort or algae in Lake Singletary, or act or do anything in relation thereto.
